Aníbal Sabater is an international arbitration specialist with nearly 30 years of experience in complex contractual and investment disputes involving projects and transactions across Latin America, North America, Europe, North Africa, the Middle East, and Asia.

Licensed in several US jurisdictions, England and Wales (solicitor), and Spain, Aníbal primarily represents clients in international arbitrations while accepting approximately three arbitrator appointments per year.

He has served in numerous multi-million dollar disputes in English or Spanish as presiding arbitrator, sole arbitrator, co-arbitrator, emergency arbitrator, and consolidation arbitrator. His service includes cases under the Rules of the AAA, CIAC/IACAC, ICC, ICDR, LCIA, SIAC, and UNCITRAL, as well as those from the Houston Maritime Arbitrators Association. He has also been an arbitrator several times in ad hoc proceedings.

Aníbal is a Fellow of the Chartered Institute of Arbitrators, an immediate past-President of the UIA Commission on the Future of the Lawyer, and a past President of the International Law Committee of the Association of the Bar of the City of New York. He is currently a member of several arbitrator panels, including those from the ICDR, SIAC, DR-CAFTA Chapter 20, the Houston Maritime Arbitrators Association, and the Central America–Chile Free Trade Agreement.
